Description

The TUSB1064Q1-EVM can be used with an alternate mode, USB Type-C[®] source such as the TUSB1146EVM or USB, or the DisplayPort[™], Type-C Host system to evaluate the Type-C implementation. The EVM comes with a legacy Type-A USB receptacle to connect to a USB hub or device, and a DisplayPort receptacle to connect to the DisplayPort sink. The TUSB1064Q1-EVM uses the TPS65987 PD controller for CC pin control and to configure the device in I²C or pin-strap mode.

1 Evaluation Module Overview

1.1 Introduction

The TUSB1064-Q1 device is a USB Type-C/VESA DisplayPort, alternate mode, redriving switch, which supports data rates up to 10Gbps for an upstream facing port (device).

This EVM user's guide describes how to bring up the EVM, and includes schematics that can be used as a reference design for alternate mode implementations of the system with the TUSB1064-Q1 device.

1.2 Kit Contents

The TUSB1064Q1-EVM includes:

- The TUSB1064-Q1 device
- (1) USB-A receptacle that connects to a USB device
- (1) DisplayPort receptacle that connects to a DisplayPort-capable sink
- (1) Standard 5V barrel jack receptacle
- Headers for configuring various TUSB1064-Q1 features

1.3 Specification




Figure 1-1. Block Diagram

Figure 1-1 shows the power and data path of the TUSB1064Q1-EVM.

1.4 Device Information

The TUSB1064-Q1 is a VESA USB Type-C alt mode redriving switch supporting USB 3.1 data rates up to 10Gbps and DisplayPort 1.4 up to 8.1Gbps for upstream facing port (sink). The device is used for UFP_D pin assignments C, D, and E from the VESA DisplayPort alt mode on USB Type-C standard.

2 Hardware

2.1 Setup

Table 2-1 lists the headers provided for the configuration of the TUSB1064 by default. The configuration settings must be optimized depending on the amount of loss of each channel in the system. The EVM is configured to GPIO mode by default. For an I²C configuration, the user must change the JMP7 (I2C_EN) shunt.

2.2 TUSB1064-Q1 Equalization Control

Users can control equalization (EQ) through I²C or pin-strapping. Each of the TUSB1064-Q1 receiver lanes has individual controls for receiver equalization (see Table 2-2). Reference the TUSB1064-Q1 data sheet for the gain values of each available combination of downstream, upstream, and DisplayPort configurations.

3 Software

3.1 Firmware Description

The TUSB1064-Q1 EVM uses the TPS65987 power delivery (PD) controller to manage the Type-C VBUS, handle configuration channel negotiation, and to set the CTL0/CTL1/FLIP pins on the TUSB1064-Q1. Users can configure the TPS65987 by loading firmware through the SPI programming header located on the side of the EVM. This evaluation module comes with pre-loaded firmware, but custom firmware can be loaded to the PD controller if certain behaviors are desired. For details on creating a custom firmware file, see the TPS6598X-CONFIG page on TI.com.




Figure 4-1. TUSB1064-Q1 EVM Schematic (Page 1)




Figure 4-2. TUSB1064-Q1 EVM Schematic (Page 2)






Figure 4-3. TUSB1064-Q1 EVM Schematic (Page 3)




Figure 4-4. TUSB1064-Q1 EVM Schematic (Page 4)




Figure 4-5. TUSB1064-Q1 EVM PCB Layer 1 (Top)




Figure 4-6. TUSB1064-Q1 EVM PCB Layer 2 (GND)







Figure 4-8. TUSB1064-Q1 EVM PCB Layer 4 (Signal)








Figure 4-10. TUSB1064-Q1 EVM PCB Layer 6 (Bottom)
